GENERAL TERMS AND CONDITIONS

These general terms and conditions are valid for every new registration. We reserve our rights to modifications and amendments of these general terms and conditions, as well as for changes of the schedule and prices.

Registration

The registration for the Ballet School Elena Abramova is a valid contract and is binding to attend the lesson until the student's deregistration in written form. The transfer to a higher level is part of the principal. For the last lesson before holidays, the parents are allowed to watch their children during lesson. The students are expected to be on time for the lesson.

School Fees

The fees need to be paid at the beginning of the Semester. Refunds will not be made due to illness or accidents. An Entry into a course is possible at any time. The school fee must be paid in cash upon entry after the autumn or spring break.

Clothing

Since 2011 the ballet school has a new dress regulation (to see on our homepage). It is expected, that the student has the ballet shoes and the correct ballet clothing. The ballet tights are optional during summer time. The hair must always be bound to a bun or tight pony tail.

House Rules

- The ballet hall is not a playground. The parents are responsible for the children between the lessons and in the waiting room.
- We ask you for silence and tidiness.
- Food and beverages are not allowed in the ballet hall and waiting room.

Vacations and Public Holidays

No ballet classes will take place on official holidays.

Absence / Illness

We would appreciate being informed by email or telephone about absences and illness. The missed lessons can be caught up during the current semester on arrangement. School fees are persisting also by absences.

Liabilities / Insurance

The school assumes no liability for accidents. The use of the school's infrastructure occurs at one's own risk. The parents or the legal guardian are responsible to check whether their child is healthy enough to attend the lesson and to cover its sufficient insurance coverage. Neither the school nor the teachers are liable for theft or the loss of valuables etc. nor for damage of personal things (the wardrobes are unsupervised).

Term of Notice

The contract can be renounced / cancelled by the end of each semester. The notice of cancellation needs to be notified in writing (letter or email) 4 weeks prior the end of the running semester or 4 weeks before the new semester begins. By quitting the contract at an early stage, the school fees are persisting until the end of the semester (no back-payments or refunds will be made by the School).

Jurisdiction

Only Swiss legislation will be applied. In case of disputes, the statutory foundation will be applied, which is the most related to this form of contract. Jurisdiction is Horgen.
